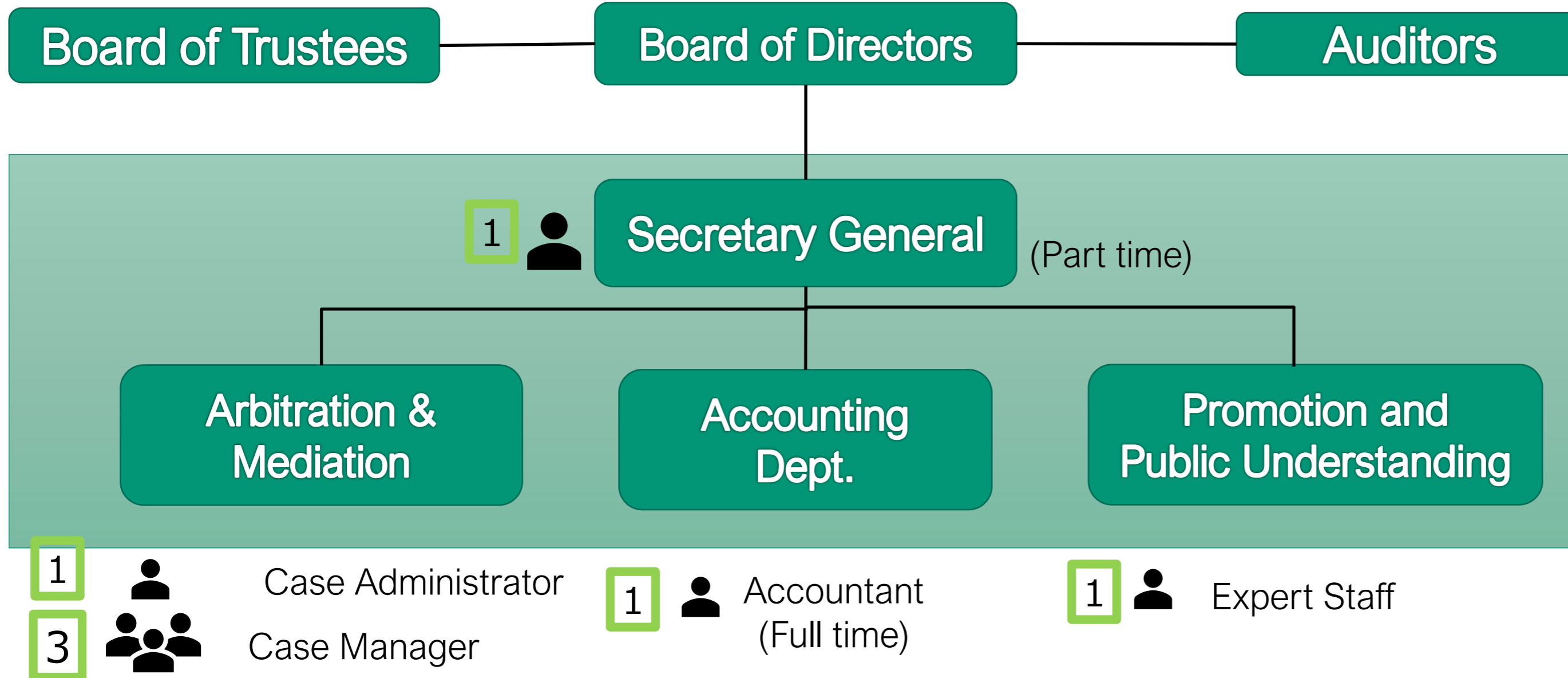

1. Board of trustees/ Directors

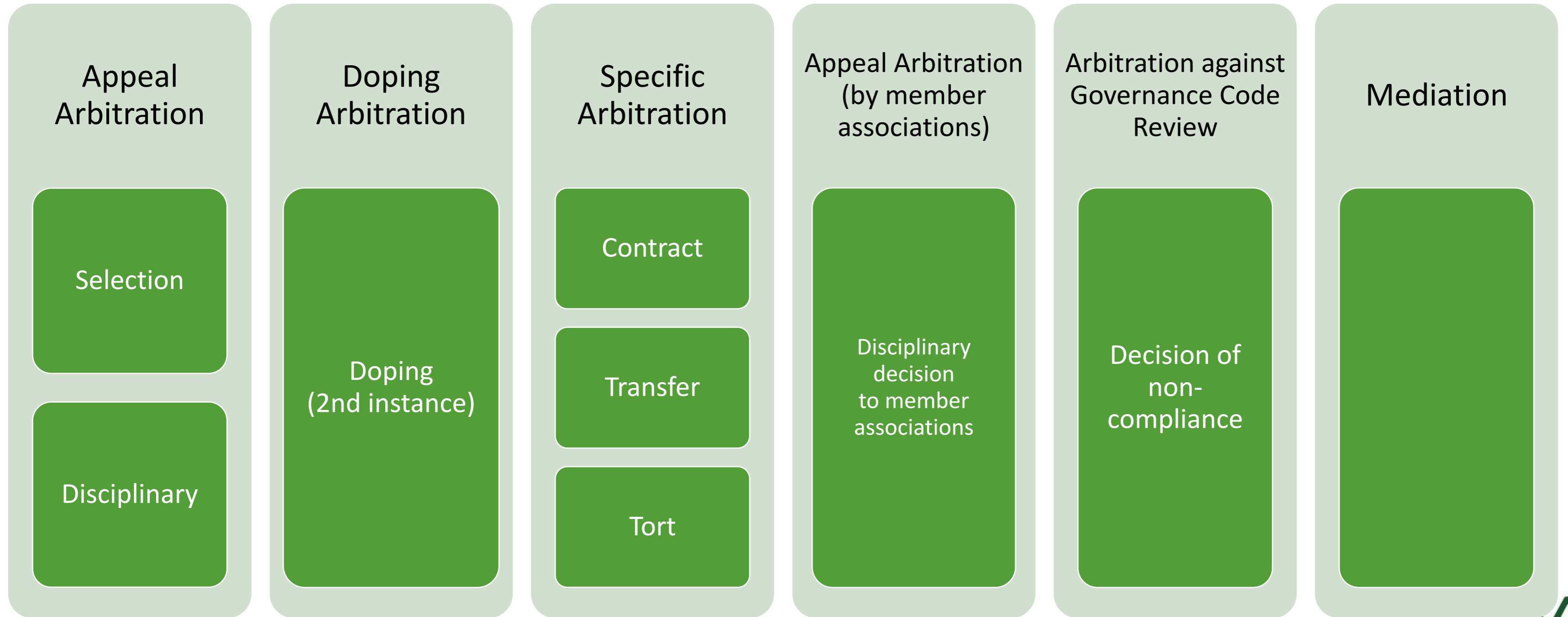
- 1 trustee from JOC / JPSA / JSPO each

- 1 million from JLPGA

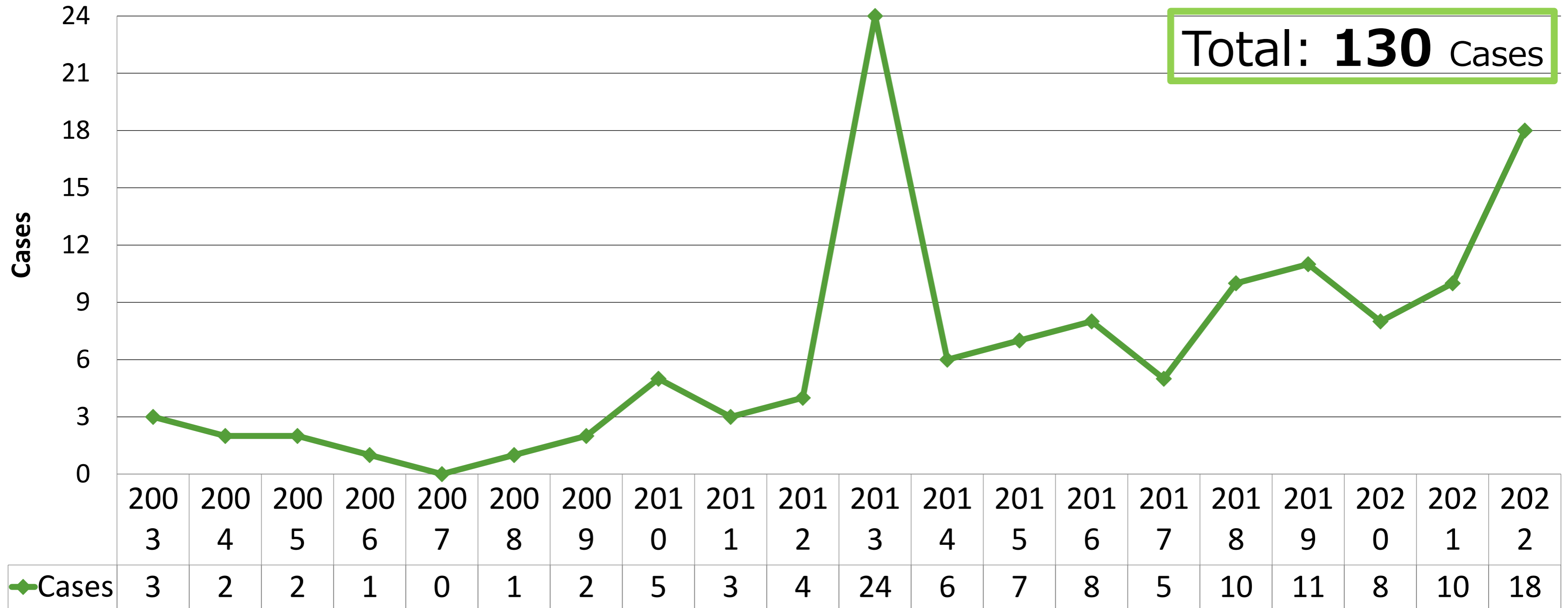

Procedures and Typical types of disputes

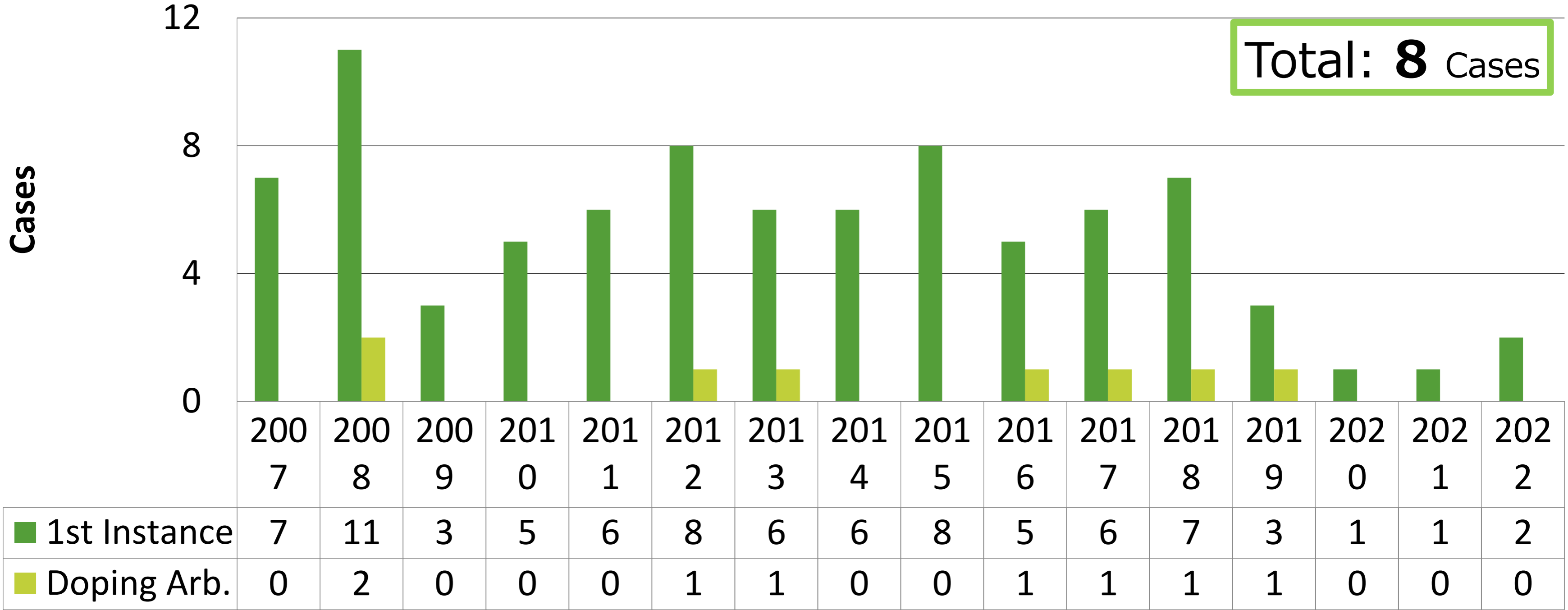


Field of Play

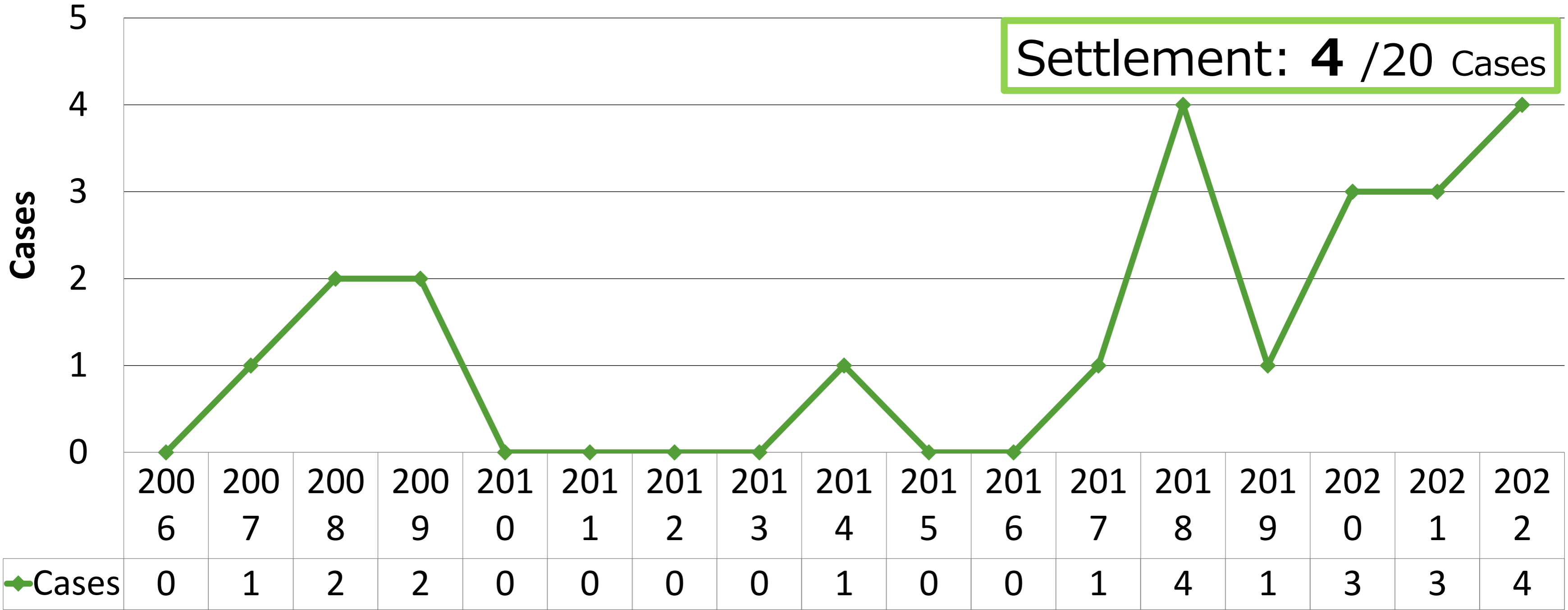
Registered Cases (Appeal Arbitration)



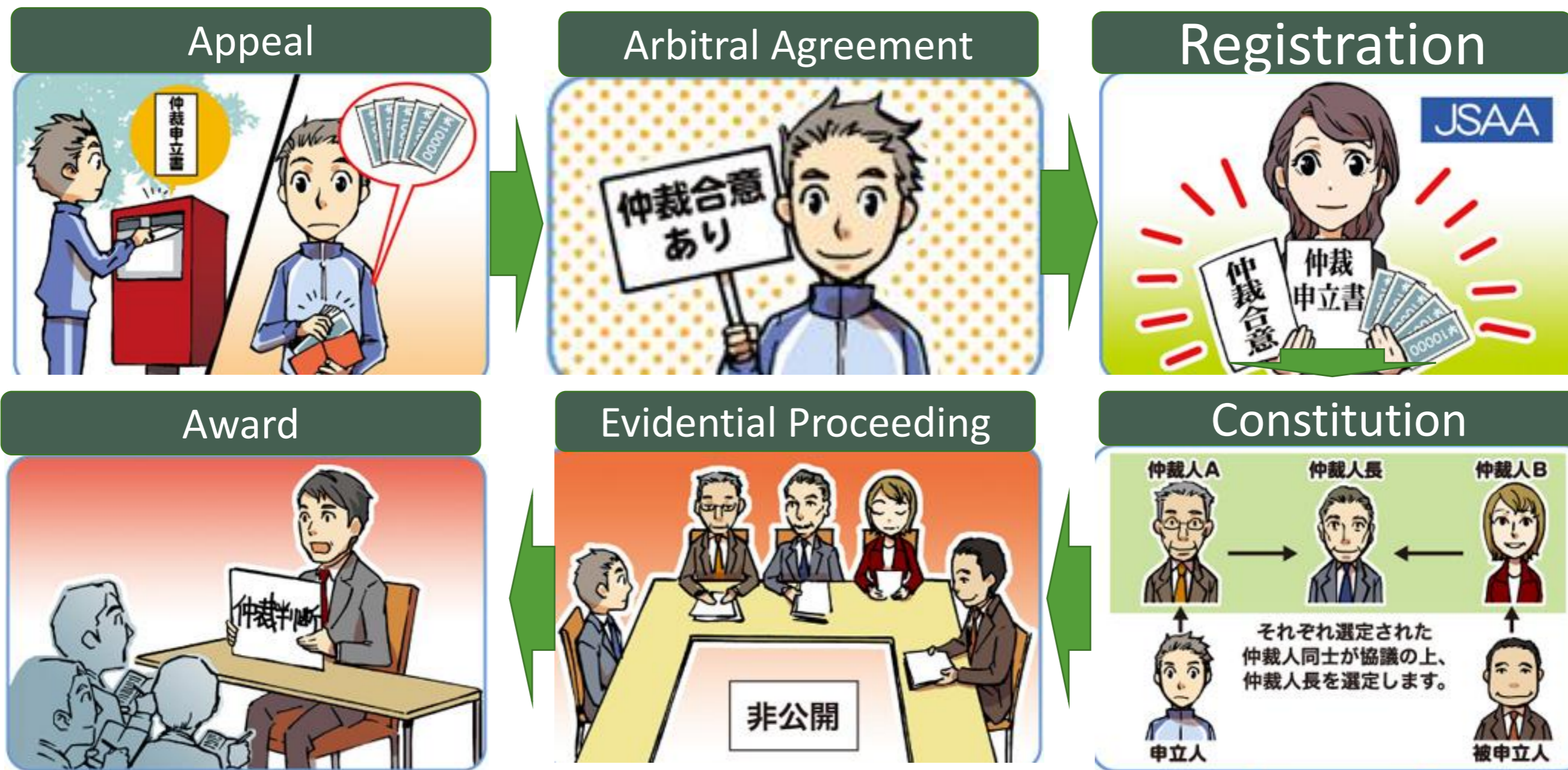
Registered Cases (Doping Arbitration)
